## Preface

Blue Cross Blue Shield of Vermont (BCBSVT) issues X12N 835 Healthcare Claim Payment Advice as mandated by the Health Insurance Portability and Accountability Act of 1996 (HIPAA). The X12N 835 version of 5010 Standards for Electronic Data Interchange Technical Report Type 3 and Errata for Health Care Claim Payment Advice is the established standard version for Healthcare transaction compliance.

This document serves as the BCBSVT Plan specific Companion Guide to 835 transaction sets. This document supplements, and is intended for use in conjunction with, the requirements in the HIPAA Implementation Guide 835 Technical report, Type 3. The purpose of this document is to clarify BCBSVT usage on specific loops, segments and data elements for X12 835 remittance advices to Trading Partners. This document is subject to revision as new versions of 835 X12 Transaction set technical reports are released.

# Trading Partner Information (TP)

## 1 TP Introduction

### 1.1 Purpose

This document is the property of Blue Cross Blue Shield of Vermont (BCBSVT) and is for use solely in your capacity as a Trading Partner of healthcare transactions with BCBSVT. This Companion Guide provides the additional trading partner information needed to successfully process 835 transaction sets from BCBSVT, and should be used in conjunction with the 835 5010A1 HIPAA Implementation Guide.

Please reference the National Electronic Data Interchange Transaction set Technical report and errata for Health Care Claim Payment Advice: ASC X12N 835 (005010X221 and 005010X221A1). ### 1.2 Scope

The Scope of this companion guide is to convey BCBSVT specific business rules around HIPAA 5010 835 X12 transactions. The instructions in this companion guide are not intended to be Standalone requirements. Please refer to 5010 835 HIPAA Implementation Guide on Washington Publishing website for complete 5010 implementation reference.

This document conveys BCBSVT specific business rules, X12 element usage and other plan specific information. The document does not duplicate or negate the X12 standard requirements for HIPAA 5010 835 transactions. For complete X12 HIPAA standard instructions, please reference the 5010 835 HIPAA Implementation Guide on the Washington Publishing website.

A BCBSVT EDI trading partner is any business partner (provider, clearinghouse, billing service, software vendor, employer, etc.) who transmits or receives electronic data from BCBSVT.

To establish a trading partner relationship with BCBSVT, it is necessary to complete a Trading Partner Agreement. BCBSVT recommends you review minimum of two 835 test files and post them successfully. When you have successfully posted these and are ready to receive Production files, contact the EDI technical support area to coordinate an implementation date.

## 3.2 Certification Requirements

BCBSVT does not have specific 835 certification requirements.

### 4.1 Process flows

Blue Cross uses SFTP to exchange any test or production file. Trading Partners can access Blue Cross SFTP site to submit X12 files. You will be provided with username and password upon receipt of a completed Trading Partner Agreement. ## 7. BCBSVT Specific business rules and limitations

This section describes BCBSVT specific usage of information in 835 file. BCBSVT will send two 835 files when the BlueCard claims transition to a new processing system. Trading Partners who submit claims for BlueCard members will receive a second 835 remittance file for BlueCard claims adjudicated in the new system.

**ENVELOPING:** BCBSVT sends a single GS-GE within a single ISA-IEA envelope. BCBSVT sends multiple ST-SE loops within the GS-GE.

**DATA CONTENT/FORMAT OF FILES:** BCBSVT sends the 835 X12 file in unwrapped format.
