Dear Provider and Home Infusion Therapy Service:

We are conducting an analysis of our community fee schedules for National Drug Codes (NDC) and Health Care Procedure Coding System (HCPCS). The focus is for the categories of administrative, miscellaneous, investigational, radiopharmaceuticals, bioengineered skin, chemotherapy drugs, drugs "administered other than oral method", enteral and parenteral therapy, select pathology, laboratory, and temporary codes.
